# **Contest Rules**

# "Photo Contest - OttO Calendar 2026"

# Article 1 - Contest Organizer

OttOmobile (hereinafter referred to as "the Organizer") is organizing a free, no-purchase-necessary contest called "*Photo Contest – OttO Calendar 2026*" (hereinafter referred to as "the Contest", also known as "*My First Car/OttO – Photo Contest*") from Friday, September 5, 2025, to Sunday, October 19, 2025, in accordance with the terms and conditions set forth in these rules.

This promotion is in no way organized, endorsed, administered by, or associated with Facebook, X, Instagram, TikTok, Google, Apple, or Microsoft. The personal data collected is intended solely for the Organizer and not for Facebook, Google, Apple, or Microsoft.

### **Article 2 – Conditions of Participation**

This free Contest is open to any individual over the age of 18 who has internet access and a valid email address. Excluded from participation are employees of the Organizer and any individuals who participated in the development of the Contest. The Contest is open exclusively to residents of the European Union and the United Kingdom.

- \* The Contest is subject to French law governing games and competitions.
- \* Participation implies full and unconditional acceptance of these rules.

## **Article 3 – How to Participate**

This Contest is conducted exclusively via email, during the dates specified in Article 1.

Only one entry per person is allowed per day (same first name, last name, and email address). The Organizer will not retain any of the email addresses provided.

Each participant must submit a photo of an OttOmobile scale model (1:12 or 1:18 scale) matching the given theme: \*\*"my first car/OttO"\*\*. Any photo not aligned with this theme will be automatically disqualified.

The photo must meet the following format requirements: 16:9 ratio in landscape orientation, with a minimum width of 3600 pixels. Photos that do not comply with this format will be automatically disqualified.

#### Article 4 - Winner Selection

Twelve (12) winners will be selected through an internal vote from among the photos that meet the technical requirements and theme. Selection will take place at the end of October by the OttOmobile team.

Winners will be contacted in the days following the selection to confirm their prize and receive instructions on how to claim it. Winners will also be announced in the comments of our posts on social media.

Any winner who fails to respond within 15 days of being notified will be deemed to have forfeited their prize.

#### Article 5 - Prizes

The Contest includes the following prizes, awarded to the selected and confirmed winners. Each winner will receive only one prize.

Prize List:

PRIZE NO. 1 (Grand Prize Winner): One (1) 1:18 scale model personalized to your specifications by our team. Personalization may include decals, new paint, or wheels from the OttO catalogue. The base model must be chosen from those available in our online store.

PRIZE NO. 2: One (1) December Club OttOmobile model (to be announced) in 1:18 scale, accompanied by a selection of OttOmobile goodies.

PRIZES NO. 3 to 12: Ten (10) models for the remaining winners. The models will be selected from those available in our online store.

# Article 6 - Prize Delivery

Winners living within a 40 km radius of Josselin (56120), as calculated by viamichelin, will be invited to collect their prize at the Organizer's headquarters.

For others, prizes will be shipped by post at the Organizer's expense.

The Organizer reserves the right to verify the identity of any winner prior to awarding the prize.

Prizes cannot be exchanged for cash or for another prize.

The Organizer cannot be held responsible for the use or non-use, or any resale, of the prizes by the winners.

In case of force majeure, the Organizer reserves the right to substitute the awarded prize with a prize of equivalent nature and value.

#### Article 7 - Identification of Winners and Disqualification

Participants authorize the verification of their identity and the accuracy of any information provided. Entries with incomplete or false information will be disqualified.

Failure to comply with these rules, or any attempt to cheat or commit fraud, will result in immediate disqualification.

#### **Article 8 – Modifications to Dates and Prizes**

The Organizer shall not be held liable in case of force majeure or events beyond its control that may result in the cancellation of the Contest.

The Organizer reserves the right to extend or shorten the participation period, to reschedule, or to modify the Contest without liability.

Any amendments or additions to these rules will be considered annexes and made available through appropriate means.

### Article 9 - Use of Winner's Identity

By accepting a prize, winners expressly authorize the Organizer to use their name, surname, and city of residence for promotional purposes, without restriction, and without receiving any compensation or rights beyond the awarded prize.

## Article 10 - Liability

Participation in the Contest implies awareness and acceptance of the risks and limitations of the internet, including potential hacking or data loss, and the risk of viruses.

The Organizer disclaims any responsibility for incidents related to computer use, internet access, or technical malfunctions.

It is the participant's responsibility to protect their data and equipment. Participation in the Contest is at the participant's own risk.

The Organizer is not liable for fraudulent use of participant login credentials or prize claims, unless gross negligence by the Organizer is proven.

The Organizer reserves the right to disqualify participants who interfere with the proper functioning of the Contest or manipulate the system.

The Organizer may suspend or modify the Contest due to technical issues or malicious behavior.

Access to the Contest or related social media content may be interrupted at any time for technical maintenance. No compensation will be granted for such interruptions.

Participants may have cookies stored on their device while accessing the Contest via social media. These cookies facilitate navigation but do not harm data.

Participants can disable cookies via their browser settings. Doing so will not prevent access to the Contest.

The Organizer is not responsible for the loss or misdirection of emails or postal deliveries. Any undelivered or unclaimed prize will be forfeited and remain the property of the Organizer.

The Organizer cannot be held responsible for internet network issues, postal service delays, or damaged deliveries.

#### **Article 12 – Data Protection Law**

Participant information will be collected and processed electronically.

In accordance with the French Data Protection Act of January 6, 1978, each participant has the right to access, rectify, or delete their personal data by writing to the Organizer at the address specified in Article 1.

The data collected complies with the GDPR. We commit to storing personal data (name, surname, email, postal address) for a period of three months only.

## Article 13 - Jurisdiction and Interpretation

Any dispute regarding the interpretation of these rules will be resolved by the Organizer.

Participation implies full acceptance of (i) these rules, (ii) standard online conduct (netiquette, good behavior guidelines), and (iii) applicable French laws on games and competitions.

No telephone or written inquiries will be answered regarding rule interpretation, Contest mechanics, or winner lists.

In case of dispute, only a registered letter with acknowledgment of receipt sent within 30 days of the Contest's end date will be considered.

Barring obvious errors, data from the Organizer's Contest systems will be considered legally binding.

Before pursuing legal action, participants agree to seek an amicable resolution with the Organizer.

French law applies. Any unresolved dispute will be referred to the competent courts of the Organizer's registered office, except where public policy dictates otherwise.
